In exchange for adopting the above-named pig, I hereby agree to the following terms and conditions: I also understand that the initials of VPP stands for VEGASPIGETS, A 501(c)(3) Federal Tax Exempt Organization.

1. I will provide proper and sufficient food, water, shelter, medical attention, vaccinations, and humane treatment for the pig at all times.
2. I will keep the pig at my residence as stated above, or if I change residence within one year following the adoption date, I will immediately notify VegasPigPets.
3. I agree to accept this pig as a companion pet and **not** as a food source. We strongly encourage you to exercise prudence and care in introducing your new pet into your home and to other pets, family members, including children, until he/she has become fully adjusted to the new environment and you have had the time to become familiar with the pet. A new pet pig is vulnerable and can be easily injured by an unfamiliar pet, other animal or child.
4. I agree to contact VPP at least twice in the first year with an update on the above-named pig's well being. If the pet pig is lost, stolen or passes away, I will notify VPP immediately. If the pet is lost or stolen, I agree to use reasonable efforts to locate the pet, including placing ads in at least two major newspapers and contacting my local animal control, animal shelter and police department. **In case of death, I will provide VPP with any medical information, including the cause of death, if known.** We agree to provide full authorization for VPP to contact our veterinarian for further information.

5. I agree that if for any reason I am no longer able to keep the above-named pig, I will give VPP first right of refusal before placing this pig on my/our own and return the pig to them or to another appropriate approved rescue organization to find a proper home. Further I will maintain a written record of the placement of the pig and notify VPP immediately should the pig not go back to VPP.
6. I release and hold harmless the previous owner, VegasPigPets, and their agents or representatives, from all claims, demands, actions, causes of action, or liabilities of any kind whatsoever.
7. I certify that I am legally able to have this pet pig at my home and have checked with the appropriate zoning officials in my township and/or county and/or HOA. I have also received express permission from my landlord, if applicable.
8. I understand VPP attempts to have all pet pigs spayed and/or neutered, however, in some cases this is not possible. If not medically advisable for the best interests of the pig to be spayed, I then agree never to allow my pet pig to be used for breeding or allow her near an un-neutered male pig, of any age. Despite every effort, should an unwanted pregnancy occur, I agree to immediately seek medical advice and attention for my pig and notify VPP immediately. Should this adoption be for a piglet that is to young or to small to spay/neuter, I agree to have the pig fixed within 60 days and send proof of spaying to VPP. Should I fail to do this, this adoption will become null and void and we shall reclaim the pig.
9. VPP shall not be responsible for any bodily injuries or property damage caused by any adopted pet pig or by the actions of its new owners. The Adopter agrees to assume sole responsibility for the pet and agrees to hold VPP harmless from any and all loss or liabilities, including all expenses, by reason of any liability or claim threatened or imposed on VPP relating to the adoption of this pet pig or it's behavior or actions following the adoption.
10. I acknowledge that this pig is being delivered to me "as is" and without any representation, guaranty, obligation, liability, or warranty, express or implied, by VPP or the previous owners.
11. All deposits and adoption donations are non refundable unless stated otherwise in the contract.
12. I understand that this statement supersedes any and all oral statements made by any owner or representative of VegasPigPets.
13. Should it become necessary for VPP to take legal action to recover an adopted pig or otherwise enforce the provisions of this agreement, the Adopter agrees to pay all court costs and attorney's fees.. I understand that if I breach this contract in any way and VPP is unable to reclaim the pig or if the pig is sold at auction or to anyone else not pre-approved of by VPP that I can be held liable for costs already incurred including, but not limited to vet bills, spay neuter fees, etc., plus any and all legal fees, court cost and any other cost pertaining to this adoption, including all medical bills incurred. The venue for enforcement of this Agreement will be in Clark County, Nevada, USA.
